



Freds Pass Rural Show Ticketing Terms and Conditions

Patron Ticketing and Entry Conditions

- All patrons must have a valid ticket to access the event.
- All persons, bags and containers are subject to a full search at entry to ensure the safety of patrons. Prohibited items will be confiscated (and only returned at FPRS's discretion except for illegal drugs), which will be handed over to police. The event organisers do not take any responsibility for confiscated items.

Dogs are not permitted entry (excepting attendance dogs – you must be prepared to show documentation).

Venue Terms & Conditions

- Entry is at own risk. The right to refuse entry is reserved.
 - Alcoholic beverages must not be taken into or out of the Venue.
 - Purchase of alcohol in the show grounds is restricted to those over 18 years of age. The only forms of valid photo ID that will be accepted for persons wishing to drink alcohol are a current Australian driver's licence, a current passport or a current state issued proof of age card.
 - Anyone found to be supplying or buying alcohol for a minor will be evicted from the Venue and will possibly face criminal charges.
 - During the event, patrons must remain on designated pathways and follow official directions by venue staff and security.
 - Trespassers and anyone assisting trespassers will be evicted from the venue.
 - Smoking is only permitted in marked designated smoking areas.
 - Pass-outs may be issued at the discretion of the FPRS.
 - The FPRS shall not be held liable for any loss, injury or damages sustained entering or within the premises.
 - As patrons of the FPRS, ticket holders' consent to being included in photos, sound and live video recordings that may be used by the promoter and approved media outlets for promotion of the event.
 - It is a condition of entry that all patrons agree not to behave in a manner that interferes with the enjoyment of other patrons. Promoters and Security reserve the right to eject any person contravening this.

Do I need to print my ticket?

No, we prefer digital tickets! Have your tickets ready on your phone to scan. If you don't have access to a phone, you can print your ticket with the bar code and present at gate.

Can I purchase tickets at the show gates?

Yes, online, cash and EFTOS purchases are available at the gates. Tickets purchased online are discounted (even taking into account booking fees) to encourage online sales and faster show entry, so buy before you get to the gates and save!

Refund Policy

There is no refund of tickets for this event. The exception is if the event is cancelled by the promoters or by a NT government health lockdown, in which case the patron is offered the option of holding the tickets over to the next FPRS or receiving a full refund (minus booking fees).
